Privacy Policy

Our Mobile Privacy Policy is designed to assist you in understanding how we collect and use the personal information you provide to us and to assist you in making informed decisions when using our site and our products and services.

What Information Do We Collect?

When you use our mobile application, you may provide us with two types of information: personal information you knowingly choose to disclose that is collected on an individual basis and mobile application use information collected on an aggregate basis as you and others use our mobile application.

Personal Information You Choose to Provide

Registration Information

You may provide us information about yourself and your practices when you register to be a member of Monique Burr Foundation, register for certain services, or register for email newsletters and alerts. You may also provide additional comments on how you see Monique Burr Foundation servicing your needs and interests.

Email Information

If you choose to correspond with us through email, we may retain the content of your email messages together with your email address and our responses.

Mobile Application Use Information

Our mobile application may collect information about how our application is used. Information gathered through may include the date and time of visits, the pages viewed, time spent at our application.

How Do We Use the Information That You Provide to Us?

Broadly speaking, we use personal information for purposes of administering and expanding our services, providing customer service and making available other products and services to our customers and prospective customers. Occasionally, we may also use the information we collect to notify you about important changes to our mobile application, new services and special offers we think you will find valuable. Sharing Information with Third Parties

We will not share or sell any personal information collected by your use of the mobile application with third parties.

Notice of New Services and Changes

Occasionally, we may also use the information we collect to notify you about important changes to our mobile application and new services we think you will find valuable. How Can You Access and Correct Your Information?

Certain Disclosures
